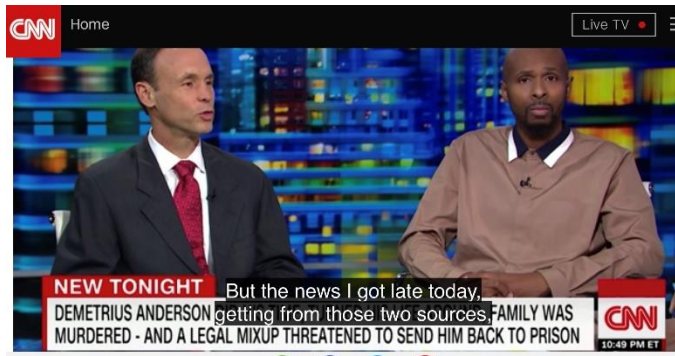

**Hang Time™ New Haven** is program satellite affiliated with **Hang Time™** satellites in Connecticut (Bridgeport, Waterbury). Through **Hang Time™ New Haven** may slightly differ in functionality, it seeks to maintain the program integrity signature to the **Hang Time™** model.

**Hang Time™ New Haven** is not a court mandated/court order program. It is not a court diversionary program.

**Hang Time™ New Haven** does not share the participant's personal information or session discussions with law enforcement agencies nor does it conduct record or background checks.

**Hang Time™ New Haven** will be a networking opportunity for individuals and community partners that will grow over time to fortify overall community wellness.

**Hang Time™ New Haven** anticipates a welcomes variety of participants, to include at risk youth from various neighborhoods throughout New Haven. Participation is entirely voluntarily and attendance will never be mandated.

**Hang Time™ New Haven** seeks to develop community partnerships to include mental health professionals that attend and develop a rapport with participants that express a voluntary need or desire for counseling.

**Hang Time™** discreet method of introducing participants to counselors has been praised by participants and community members for giving a choice to those in need of therapy. In addition,

**Hang Time™ New Haven** will utilize existing relationships with the City of New Haven's Re-Entry Program, New Haven Family Alliances Street Outreach Workers Program and other agencies like Project Moore.

**Hang Time™ New Haven** will also seek to foster relationships with businesses for job opportunities as well as housing needs.

**HISTORY OF HANG TIME™** In December 2014, Charles Grady created and launched a grassroots effort to foster community and give voice to men and women (ex-offenders/returning citizens) who had been silent—or unheard—for far too long. The targeted group were those involved with gang/group violence and those that inherently suffered from Post-Traumatic & Present Stress Disorder (PTSD) which resulted from urban gun violence. To jump start the effort, Grady formed a small cadre comprised of ex-offenders, a federal prosecutor, a local police officer, and social service workers to brainstorm on a format that would be successful. The result is now known as **Hang Time™**.
